



Conditions of Rental Agreement

DELIVERY TO ADDRESS SPECIFIED BY THE LESSEE (CUSTOMER). LESSEE GRANTS TO ENTER SAID PROPERTY FOR THE DELIVERY AND PICKUP OF EQUIPMENT AT APPROXIMATELY SPECIFIED TIMES.

To Place an Order

- Clients must pay 50% of the total upon placing the order.
- We need a Full Name, Delivery time, Pick up time, phone number, & delivery address of the event. A phone number and onsite contact person with a cell phone number if possible.
- Balance is due before items are released to a customer.
- We accept Credit Cards, PayPal, Checks, and Cash.
- There will be no return on deposits for orders canceled within 30 days of the event.
- Credit will be given for orders canceled 29 days prior to the event.
- Please notify us if any reductions or additions are to be made to your order 2 days prior to the event.

Delivery Charge

- A normal/standard delivery charge is based on the amount of the rent and distance from our address
- Our delivery charges are for delivery and pickup to the event **setup and breakdown is an** additional fee.
- If on delivery the client requests more items, we will charge another "delivery charge" according to the new order.
- PLEASE CHECK THE COUNT AND CONDITIONS OF YOUR ORDER IF YOU SEE A SHORTAGE OR DAMAGE TO ANY OF THE ITEMS RECEIVED PLEASE CALL IMMEDIATELY.

Table & Chairs

If setup & breakdown fee was not applied

- Tables & Chairs will be left stacked, in carts, & in protection bags/covers
- After event chairs and tables must be stacked back on carts and put back into protective bags/covers as received
- FEE will be applied if not done so

Signature of Lessee

Damaged or lost rental items

- If the event rental property is not returned, or is returned in a broken or otherwise damaged condition, the customer will be charged at cost price thereof, and shall be due and payable upon billing in addition to the rental charge.
- For outdoor events, it is highly important to keep any furniture or items rented from exposure to any possible damage from the elements. If pick up has been scheduled for the following day the items must be protected by being placed in storage or canopies.
